CityHeart quickly pivoted operations to meet required restrictions, focused attention on how to continue our mission, formulated a plan to keep volunteers and staff safe, and adjusted throughout the year on how to best deliver services for as many families as possible.

CityHeart was determined to survive the crisis, because our neighbors would need us! We knew the people served by our program would be one of the most vulnerable populations affected. As the economy slowed hard working people lost their jobs without any margin money.

CityHeart remained available to meet immediate needs, to help fill gaps in services, to offer critical information and referral services, and assist financially. We are an important piece of the puzzle in resolving emergency situations. With compassion and care, we bring hope to the lives of all the people served by CityHeart.

A Letter from the Board Chair

Dear Friends of CityHeart,

M. Scott Peck's book, "The Road Less Traveled," was on the New York Times best seller list for 10 consecutive years. The very first sentence of the book simply reads: "Life is Difficult." Yes, under normal circumstances life is difficult. In 2020, life became extremely difficult. Suddenly our world turned upside down. Everything began with no; no job, no school, no church, no......unfamiliar words became part of our regular vocabulary; unprecedented, pandemic, social distancing, and zoom.

In the summer of 2018 the CityHeart Board created a strategic plan that spans 2018 through 2020. Goals were established in four areas. Board Development, Operations, Finance-Fundraising and Marketing.

In March of 2020, a Strategic Plan Crisis Response Team was created within the Board to consider the impact of COVID-19 on our current Strategic Plan. The Team met for 6 months beginning in July, to measure the impacts of the pandemic on our Strategic Plan. The Team found negative and positive outcomes, and provided recommendations to the full Board and staff. No substantive changes were made to the plan, it will be extended through 2021 to accomplish final goals. Presidents' Report & Executive Summary of Board Committees

The year 2020 has been the most challenging year for me and for CityHeart since the Great Recession of 2008. The similarities are that people hit the hardest in both crisis are people of color and low income wage earners. These are the people identified in the mission of CityHeart - to serve the homeless, poor and marginalized. They have always been one paycheck away from crisis and they have now lost their livelihood at a staggering rate. I am so thankful for our staff and volunteers that have enabled CityHeart to be part of the solution for them. I am thankful for the support of our board and their willingness to work through this difficult time, focusing on the philosophy—survive to thrive! Together we have worked to accomplish these immediate goals:

- ◆Sustainability of CityHeart during COVID-19
- ◆Keeping CityHeart Mission Centric
- ◆Ensuring the Safety of Staff and Volunteers
- ◆Maintaining Critical Collaborative Partnerships
- ◆ Providing Relief and Connections for Clients
- ◆Raising Funds for Expanded COVID Response

The Committees of the Board have focused on objectives of our strategic plan while recognizing and adjusting to potential impacts of the pandemic. Highlights of 2020 include:

Governance Committee

- •Worked with Pro Bono Partnership of Ohio to establish recommended policies
- Continued work to establish policies for application and compliance with BBB Nonprofit Standards of Accountability
- Policies Approved in 2020: Diversity Policy, Whistleblower Policy, Document Retention & Destruction Policy
- Worked with Executive Director & Board Chair on Nomination of New Board Members for 2021-2024

Human Resources Committee

- •Worked w/Executive Director to hire part time staff in position of Bookkeeper
- •Worked on HR Committee leadership transition
- •Conducted Annual Evaluation of Executive Director
- Negative impacts of COVID: forced remote operations, difficulty in training of new bookkeeper, reduction in volunteer staff
- Positive outcomes of COVID: Maintained 1 Full Time and 2
 Part Time staff during the crisis, secured by PPP loan

Development Committee

- •COVID Appeal in April helped to stabilize organization
- •Early and intense planning for shifting Fall Fundraiser to a virtual event
- •Virtual Fundraiser resulted in new donors & new pledges
- •Overall giving increased, online giving increased

Operations/Crisis Response

- ●COVID forced Remote operations March May
- Reentry Task Force met weekly April June for Phase 1 of Office Restart
- Followed all State of Ohio & CDC guidelines for safety of staff
 & volunteers
- Negative Impact of COVID: Reduction in volunteer staff to due capacity limits, remote operations difficult, IT project put on hold due to uncertainty of finances, heightened awareness of network security
- Positive Outcomes of COVID: ability to quickly pivot to remote, never fully closed for client services, discovered new ways of doing things, greater partner collaboration, NO COVID spread



CITYHEART HELPS TO BRIDGE THE GAPS—A Story of One Family

Andrea reached out to CityHeart for help in July, just after protections for disconnections were lifted by the utility companies.

She needed help with a water bill and had exhausted all her options. She didn't qualify for help from other local agencies. Like so many people, Andrea used all her resources in helping her sisters who were both laid off and had lost income due to COVID. Then she ended up falling behind on her own bills. The uncertain times really put pressure on families. Struggling herself, she realized that she may not have made the best decisions, but it was her family and she felt compelled, because family helps family!

"I am a worrier...no, I am a WARRIOR," Andrea said. "I take care of my mother with Dementia, and helped my family putting me behind on my bills. COVID has really affected my family. But CityHeart was understanding and worked quickly to help me in my time of despair and worry. I was treated with total respect...I didn't feel like just a number. The person on the other end of the phone was genuine...sent by God. You are there, and you care...It can save someone's sanity, someone's life."

CityHeart was able to help resolve the payment of the water bill and give this family much needed referrals. Overwhelmed with gratitude, Andrea said she wants to find a way to back it back, or to "pay it forward". We recommended she take care of herself first, then help take care of her family, that is paying it forward!

Maintaining Critical Connections with our Partners In Mission

Kudos to staff member Anthony Ehresmann who has worked tirelessly throughout the pandemic to coordinate Program Services and cement our collaborative partnerships. Knowing what resources are available at any given time and communicating this to staff, volunteers, clients and other service providers, has permitted CityHeart to be on the critical path for solutions. These connections are imperative in assisting our mutual clients for the best and most timely response. CityHeart works with our partners to bridge the gaps, we especially want to thank the folks at St. Vincent DePaul, Salvation Army and Miami Valley Community Action Partnership. In 2020 CityHeart provided 1759 referrals to 809 households resulting in thousands of dollars in aid.

Hospitality looks different, but we are still trying to help.

Sack lunches and bus passes have been available for "walk-up" clients by passing items out the door. And in December, Anthony and his husband Matt donated backpacks filled with winter weather items. We gave these out at CityHeart and each of us also

carried them in our cars to hand out on the streets and at the highway ramps.





Highlights:


- ◆ Raised \$35,803 in individual donations, pledges, and online auction—\$5000 over our goal!
